Identification of sustainable business development opportunities, environmental services payment, low carbon programs, and environmental assets (forests, biodiversity, water resources and carbon).

M&A and financial transactions

Analysis and mitigation of environment-related risks arising from mergers and acquisitions and financial market transactions, as well as issuance of green securities.

Socio-environmental responsibility of financial institutions

Analysis of compliance risks related to regulations concerning socio-environmental responsibilities by financial institutions and companies to adjust to the
